In fiscal year 2019, 572 students collectively received \$1.1M in scholarship support through one or more of CMC Foundation's 215 named scholarships. 56 of our scholarships are endowed; representing \$13.2M in endowed scholarship support within the CMC Foundation, and generations of students whose lives will be changed through these scholarships that will exist in perpetuity. concurrent enrollment, college counseling support and enrollment, credit loads per student and student persistence. In fiscal year 2019 the CMC Foundation also took in donations in support of two new programs that are also garnering broad support and exposure: "Fund Sueos" and CMC's "Rural Teacher Education Fellowship Program". Fund Sueos, funded entirely by philanthropic gifts, provides access to Income Share Agreements for any student who has workforce authorization, but no access to federal aid, including our DACA students. CMC's model is the first of its kind in the nation. CMC's Rural School Teaching Fellowship Program is designed to provide every teacher candidate who agrees to student teach in one of our local schools with a \$10,000 housing stipend and a guarantee of a job in the district. This \$10,000 stipend is funded half by the state of Colorado through recently passed legislation and requires a 50% (\$5,000) private match per fellow.
